# Water conservation projects of Vedanta Iron Ore Karnataka continues to promote Agriculture across Chitradurga

~Vedanta Iron Ore Karnataka Business provides agricultural assistance and helping to create Livelihood opportunities across Chitradurga district under ALOP project.

Chitradurga, 19<sup>th</sup> September, 2020: Vedanta Iron Ore Karnataka under its umbrella program – Alternate Livelihood Opportunity Project (ALOP) is providing agriculture assistance and creating sustainable livelihood opportunities for the communities around. Recently company has initiated Water conservation measures at Bheemsamudra village and Muthugaduru through desilting of village Ponds with aim to mitigate the water crisis in Chitradurga District and create adequate irrigation facilities for revival of Agriculture. This project was initiated in association with Bhartiya Agro Industries Foundation (BAIF) in order to improve the fertility of the Agriculture land and to infiltrate the water in designated tank areas that will thereby increase the ground water table. Vedanta Iron Ore Karnataka through 'Desilting of Village Ponds' so far, has benefitted over 271 families from Chitradurga.

Under this initiative a cumulative of 20000 CMT has been excavated at Bheemsamudra and Muthugaduru villages to enhance the capacity of water reservoirs. The excavated silt is effectively utilized for improving the soil fertility of nearby Agricultural land under cultivation and for embankments. Villagers appreciated Vedanta for taking up such an initiative in this drought stricken area and are extremely hopeful of enhancement in crop yield in the seasons to come.

Expressing her views Ms. Leena Verenkar, Group CSR Head- Vedanta Resources Limited said "At Vedanta we are fully committed towards Socio-Economic upliftment of communities through our structured CSR Interventions. Farmer Basavarajappa S Hanumantappa Gowdru, Nellikatte village Said "I applied the silt to my Arecanut farm. And it will help in maintaining the fertility of soil for the next five years and no fertilizers needed to the Arecanut plants. My yield has been almost doubled. Earlier my yield was 6 quintal and now I'm getting around 12 quintals of yield. I would like to express my sincere gratitude towards Vedanta Iron Ore Karnataka for such useful initiatives in order to enhance our farm yields and also the BAIF team for implementing this activity in our village."

ALOP is a continuous project which mainly focuses on education on improved development in farming and the creation of alternate enterprises for sustainable livelihood which includes activities such as Community mobilization, Training and capacity building, Promotion of Horticulture plantation, Establishment of Cattle breeding centers etc. The projects has reached out to over 802 families across the state over last several years.
