- As part of drinking water project 4000 LPH RO plant was installed to provide access to clean & safe drinking water to communities around.

19th March 2021: Vedanta's VGCB recently launched drinking water project which will benefit over 2000 households from Visakhapatnam. As a part of CSR initiative, Vedanta's VGCB installed 4000 LPH capacity RO plant which is providing clean and safe drinking water supply to communities at very nominal cost. Earlier the project was launched in the distinguished presence of Honorable Mayor of Visakhapatnam Smt. After the successful installation and commissioning, the plant was handed over for complete operation and maintenance to Old Town Development Committee, Visakhapatnam.
