The 'Cage Fishing project' was inaugurated in the distinguished presence of superintendent of Directorate of fisheries- Mr.Chandresh Haldankar, Director of Vedanta, VAB- Mr.Saptesh Sardesai, Sasticho Akh Tenant Association President Mr. Damodar Naik, Sesa Goa Workers union leaders Mr.Anant Gawas along with the members of Sasticho Akh tenant Association, team members from Vedanta and other villagers.

Vedanta's VAB provided complete infrastructure for setting up cage fishing project at Navelim village including 4 cages, inner and outer net, barrels, and other accessories for the project initiation.
